As an Intermediary of the Social Innovation and Entrepreneurship Development Fund (SIE Fund), the Hong Kong Council of Social Service (HKCSS) launches the Impact Incubator, a one-stop supporting platform with a mission to bring positive social impact through incubating social entrepreneurs and bridging social capital.

配對基金 Matching Fund



「創業」及「擴大規模」兩種資助計劃的申請者均須在申請前承諾配對不少於總項目預算之50%的配對基金[^]。(配對比例以最高1比1計算)。 Impact Incubator設立好好創投基金Good Impact Fund,為具潛力的創新項目匯聚更多額外資金作配對。

Applicants of 'Start Up' and 'Scale Up' projects shall commit to solicit at least 50% of total budget as matching fund before application. (The highest matching scale is 1:1). Impact Incubator establishes Good Impact Fund to leverage extra financial resources from private donors, foundation and social investors for project matching.
